Madam/Sir,

On behalf of the Director-General, I have the honor to inform you that the Intergovernmental Council of the International Hydrological Programme (IHP) will hold its 19<sup>th</sup> session from 5 to 9 July 2010 at UNESCO Headquarters, Paris.

During this session, the Council will principally examine the relevant outcomes of the 35<sup>th</sup> session of UNESCO's General Conference, including the Organization's Programme and Budget for 2010-2011 (35 C/5), particularly as these relate to the implementation of the Seventh Phase of IHP (IHP-VII, 2008-2013). The Council will also, *inter alia*, look into recent institutional developments in IHP, review progress on the implementation of the resolutions and other recommendations adopted by the 18<sup>th</sup> session of the IHP Council (Paris, June 2008), examine the status of UNESCO's water-related category 1 institute and category 2 centres under its auspices, and report on the formulation of the Eighth Phase of IHP (IHP-VIII, 2014 – 2019, including the endorsement of the related concept paper.

Pursuant to the decision of the IHP Bureau, at its 43<sup>rd</sup> session (Paris, June 2009), to adopt a different format for the forthcoming 19<sup>th</sup> session of the IHP Council, a three-hour public presentation on a specific scientific area of IHP will be integrated into the Council session. This scientific segment – the subject of which will be communicated at a later date – would serve as an outreach activity addressing both the IHP scientific community and policy makers from UNESCO Member States.

Please find enclosed the provisional agenda of the session, together with the Council's Rules of Procedure. The documents for the session will be announced and made available on the IHP website [http://www.unesco.org/water/ihp] sufficiently in advance of the session of the Intergovernmental Council.
